Gift Aid Declaration

Please treat as Gift Aid donations all qualifying gifts of money made today. I confirm I have paid or will pay an amount of Income Tax and/or Capital Gains Tax for each tax year (6 April to 5 April) that is at least equal to the amount of tax that all the charities or Community Amateur Sports Clubs that I will donate to will reclaim on my gifts for that year. I understand the charity will reclaim 25p of tax on every £1 that I give.

This means that for the U3A subscription only, you need to pay £3 in tax every year. If you pay amounts to other charities and claim Gift Aid, a similar calculation will need to be made.
